- 1. I will treat all human and nonhuman animals with respect and I will work as a team member with all volunteers. I understand that my opinions are considered valuable to the Animal CARE Foundation and will provide them openly, knowing that they will be respected and appreciated, but may not be acted on.
- 2. I fully understand that the Animal CARE Foundation expects high standards of moral and ethical treatment of the animals under its care. I agree to adhere strictly to these standards in my voluntary capacity to the Animal Care Foundation. These standards are set forth in the policies set forth in paragraph 3, below.
- 3. I will be provided with the Animal CARE Foundation's "Rules, Policies and Procedures." I agree to familiarize myself with them, and will fully comply with their letter and the spirit.
- 4. I fully understand and agree to provide my services to the Animal CARE Foundation as a volunteer in a voluntary capacity without any express or implied promise of salary, compensation, or payment of any kind whatsoever.
- 5. I fully understand and agree to provide my services to the Animal CARE Foundation as a volunteer in a voluntary capacity without any employment-type benefits, including but not limited to, employment insurance programs, worker's comp, and/or an accrual in any form, such as vacation or sick time.
- 6. I agree to be supervised as appropriate by the Animal CARE Foundation personnel and will report any problems that arise directly to the proper Animal CARE Foundation representative. I agree to act as my supervisor instructs.
- 7. I understand the possible risk of transferring disease-causing microorganisms from the Animal CARE Foundation foster homes or offsite adoption venues to my personal animals or vice versa and must have current vaccinations for animals at home. If my personal animals are unable to have vaccinations for any reason, I will inform the proper Animal CARE Foundation representative immediately. I fully understand that the Animal CARE Foundation handles rescued dogs, cats, and others. The disposition of these animals is unknown to the Animal CARE Foundation and I agree to hold the Animal CARE Foundation harmless for any injury(-ies) which I might sustain from handling animals during the course

of my volunteer duties with the Animal CARE Foundation.

- 8. I fully understand and agree to assume all risks involved in any and all duties I perform for the Animal CARE Foundation in my voluntary capacity. Such duties might include, but are not limited to, animal handling, custodial work, and other volunteer duties.
- 9. I understand the potential safety risks of working with animals and that I may not bring friends or relatives with me while volunteering for the Animal CARE Foundation, unless they have also submitted a Volunteer Agreement and Waiver of Liability, or prior arrangements have been made in advance with the Animal CARE Foundation personnel.
- 10. I am current on my tetanus vaccination and covered by a health insurance plan. I SPECIFICALLY WAIVE ANY LIABILITY FOR ANY INJURY INCURRED IF I HAVE NOT COMPLIED WITH THIS PARAGRAPH.
- 11. I authorize the Animal CARE Foundation volunteers to seek emergency medical treatment for me in case of accident, injury or illness, and agree to be personally liable therefor. I hereby release the Animal CARE Foundation, its employees, agents, officers, and other volunteers of any liability for any medical treatment obtained at the request of the Animal CARE Foundation and its employees, agents or volunteers.
- 12. I agree to indemnify and hold harmless the Animal CARE Foundation, its officers, agents, and volunteers from and against any and all liability whatsoever arising out of or related to my duties under this agreement or for any negligent act or omission by the Animal CARE Foundation, its officers, agents, and volunteers. I understand that as a small animal rescue group, the Animal CARE Foundation cannot afford to be held liable for negligence or deliberate acts that might cause any harm.
- 13. This agreement is subject to change by the Animal CARE Foundation personnel.
- 14. If I fail to abide by the terms of this Agreement or am otherwise unable to meet the requirements of the volunteer program, I understand that I will be terminated from the program. I also understand that at any time I may be removed from my position as a volunteer at the discretion of the Animal CARE Foundation. However, as the Animal CARE Foundation relies on good volunteers, we really need you and like having you around. If you are nice to the animals all the time, and to us and all the other volunteers most of the time, you will be good-to-go.
